After confirmation of Brazil as the host nation for the 2014 World Cup and Rio de Janeiro as the host city for the 2016 Olympic Games, **Demarest e Almeida** prepared a multi-disciplinary team with knowledge and expertise in several Law segments, to meet all possible demands related to those events.

With a budget estimated at one hundred (R\$ 100) billion *Reais*, the 2014 World Cup ("Cup"), shall be the largest sports event ever held in the history of the country, comparable only to the 2016 Olympic Games, an event which will be hosted in the City of Rio de Janeiro and will have a budget of approximately thirty-four billion *Reais* (R\$ 34 billion).

These events not sufficing to catch the world's attention, a number of related events will be hosted in Brazil, such as the 2013 Confederations Cup, 2016 Paralympics Games and the Peace Games.

In view of the magnitude of such events, Brazil is already catching the world's attention for the business opportunities that will be opened within the next seven years. Investors from all over the world are seeking several possibilities involving the most diversified market segments.

In order to assure the investors' safety, the Brazilian government has shown concerns about several regulatory issues, whether by creating mechanisms to facilitate the required massive investments, or waiving investors from heavy tax burdens, and lastly, adapting current laws in order to protect such investments.

Similarly, the monitoring of funds invested on works needed for the events has been one of the major concerns of the event organizers as well as society as a whole, and recently several inspection commissions were organized within the Legislative and Executive branches.

Direct investment opportunities are being constantly opened to companies with activities in different markets, from civil construction to the hotel segment. Likewise, partnership opportunities in these diversified segments, whether local or international, are being unfolded. Undoubtedly, Brazil is arising as an attractive country for investments.

III. **Future Demand Segments in Brazil**

Undoubtedly, investments in infrastructure in view of the World Cup and Olympic Games in Brazil require significant amounts. It is worth recalling that these investments involve the most diversified business segments, such as:

Construction

Planning and execution of all stages of building works on infrastructure, transportation and leisure, further to refurbishment and construction of sports stadiums and arenas.

Cement & Steel Industry

As a result of diversified investments in civil construction, the cement industry foresees a significant increase in the next years, as well as the steel industry, concerning steel production and treatment.

Sanitation

Development of several measures at the host cities aiming at improving the sanitary conditions of a certain region through the appropriate sewage, water distribution and garbage administration treatment.

Power

Development of undertakings related to the production and distribution of different forms of power to meet the demand that the infrastructure works will generate, always seeking the implementation of alternative power in such undertakings, to cause less impact to the environment.

Real Estate Development

Construction and sale of infrastructure undertakings in the host cities, such as hotels, apartments, flats or any other means of accommodations for the tourists expected to visit all host cities.

Hotel and Tourism

Development of activities related to the construction and/or management of tourism and leisure undertakings in the host cities.

Airports and Ports

The great increase in demand caused by those sports events will require considerable refurbishment works of the airports in cities hosting the World Cup and Olympic Games.

Ground Transportation

Performance of the road infrastructure works required to improve the ground transportation structure at the cities involved in the events.

Publicity

Development of projects intended to advertise ideas associated with the competitions as well as negotiations of sponsorship quotas for the events, in different media.

Technology

The global aspect of both competitions will demand the development of products and services of information dissemination, communications, Internet and broadcasting of the competitions to the entire world. Likewise, the indirect demand for technology applicable to infrastructure works will be considerable.

Language Courses

Development of language courses, especially English and Spanish, in the host cities, to qualify the local population to receive the great number of tourists that the country will attract by hosting the two competitions.

Food

The great number of tourists expected to visit the host cities will require the implementation of new food businesses in the cities hosting the events.

In summary, there are different opportunities in various segments and regions. This variety of opportunities is what makes Brazil the country for investments, combined with several other positive features that the country has showed internationally in the past years. Some of these opportunities are detailed below.

IV. **Business Opportunities in the Host Cities¹**

Belo Horizonte - MG

Population: 2.434.642

Gross domestic product (GDP) per capita: R\$ 13.600,00

Airport and Port Works

- ✓ Improvements on Pampulha Airport facilities (budget of R\$ 7 million); and
- ✓ General improvements and renovation of the passengers terminal on Confins Airport (budget of R\$ 342,3 millions).

Ground Transportation Works

- ✓ Expansion of the subway system (budget of R\$ 3,4 billion and expected delivery in 2013);
- ✓ Renovation of the overall structure and refurbishment of the passenger terminal at Confins Airport (budget of R\$ 342,3 million);
- ✓ BRTs (*Bus Rapid Transits*) Implementation Projects. It was published in March 2010 the invitation to bid for the works of BRT in Belo Horizonte. According to BHTrans, the routes shall be available for operation by June 2012 and the public investment planned for this project is approximately R\$ 493 millions; and
- ✓ Minas Gerais government is concluding multiple ground transportation works which will bring innumerable benefits to the city, as a World Cup host city.

Stadium Renovation / Construction

- ✓ Renovation of Governador Magalhães Pinto (Mineirão) Stadium (budget of R\$ 300 million and expected delivery in December, 2012). The renovation process of Mineirão Stadium shall be done in three stages. The first stage has already started and consists on the strengthening and reform of the structure of the stadium. The value of this first stage is approximately R\$ 8,345,855.39. The other two stages shall be started after the conclusion of this first stage. Until now, only the bidding documents of the first stage of the project were published. Please note that, regarding this first stage, the interested companies should participate individually, not being allowed to participate in consortiums; and
- ✓ Implementation project of solar panels in Mineirão Stadium, in order to produce the electrical energy that is going to be consumed by the Stadium.

Hotel Works

- ✓ Creation of approximately 6000 beds (through new hotels construction) in the city of Belo Horizonte until the end of 2010; and
- ✓ Minas Gerais Development Bank (BDMG) shall introduce in the market a credit facility to businesses related to the hotel segment carried out in a 100km sphere from Belo Horizonte.

General Information

- ✓ Minas Gerais government estimates that all public works shall be financed through four systems: (i) funds from "PAC da Copa", (ii) Municipal and State Governments' own budget, (iii) BNDES financing; (iv) besides the PPPs; and
- ✓ Considering the most relevant construction and all others small constructions in the city of Belo Horizonte, the Municipal Government estimates outlays of approximately R\$ 6 billion.

Brasília - DF

Population: 2,455,903

Gross domestic product (GDP) per capita: R\$ 37,600.00

Airport and Port Works

- ✓ Renovation and refurbishment works at Presidente Juscelino Kubitschek Airport (budget of approximately R\$1.3 billion). The reform and modernization process will begin in September 2010 and expect delivery in the end of 2015. As much as the works will not be completed until the beginning of the 2014 World Cup, the government's expectation is that the capacity of the airport will be expanded to 26 million passengers per year.

Ground Transportation Works

- ✓ Construction of a VLT (Light Rail Transit Vehicle) (budget of approximately R\$ 2 billions, to be financed by BNDES and the GDF Based on the fact that the project was blocked by the courts until May, 2010, the bidding documents have not been published yet but the government's expectation is to publish this document until the second semester of 2010.
- ✓ Regarding the subway expansion, according to the works description document published by Companhia do Metropolitano do Distrito Federal, the estimated value of the project is approximately R\$ 1,33 billion and the deadline for completion is approximately 60 months, from the moment of the publication of the bidding process results. The project shall be financed through PAC da Mobilidade and BNDES; and
- ✓ Improvements and expansion of the ground transportation system (budget of approximately R\$ 2 billion and expected delivery in 2010).

Stadium Renovation / Construction

- ✓ Renovation and refurbishment of Mané Garrincha Stadium - change of stadium name to National Brasília Stadium being speculated (budget of approximately R\$ 600 million);
- ✓ There is already a PPP (Public Private Partnership) project for more than a year involving the works on Mané Garrincha Stadium. The invitation to bid to pre-qualify the company that will present proposals for the works was published on July 06, 2009, setting a term until August of same year for presentation and opening of the proposals by Companhia Urbanizadora da Nova Capital do Brasil (Urban Planning Company of the New Capital of Brazil), which is in charge of the bid. According to the government's estimates, the invitation to bid should had been published by the beginning of 2010 but, because of a legal impediment made by the Federal Public Finance Court, the bidding process was restarted on May 2010.
- ✓ Spanish group Rayet already expressed its interest in the works on Mané Garrincha Stadium. Mendes Júnior also expressed the same interest.

Hotel Works

- ✓ Expansion of the hotel network by approximately 10 thousand beds.

Technology

- ✓ Installation of *wireless* digital tower, covering the entire Pilot Plan (budget of approximately R\$ 20 million).

Cuiabá - MT

Population: 544,737

Gross domestic product (GDP) per capita: R\$ 10,025.00

Airports and Ports Works

- ✓ Renovation of A and B wings of Marechal Rondon Airport (budget of approximately R\$ 60 million and expected delivery in June, 2013).

Ground Transportation Works

- ✓ General urban mobility works (budget of approximately R\$ 2.4 billion);
- ✓ Cuiabá intends to implement the BRT (Bus Rapid Transit) project, among more than a score of urban mobility projects. The works are scheduled to start by December, 2010, to be fully implemented until July, 2012. (budget of approximately R\$ 317 million);
- ✓ General infrastructure works in the city (budget of approximately R\$ 1.4 billion).

Stadium Renovation / Construction

- ✓ Construction of the new Governador José Fragelli - Verdão Stadium, with expected capacity of 42 thousand spectators (budget of approximately R\$ 430 million and expected delivery in December 2012). After the World Cup, Verdão Stadium shall be managed through public concession. The consortium Santa Bárbara/Mendes Júnior won the bidding process and the supervision of the works shall be provided by the engineer company Concremat Engenharia e Tecnologia S/A;
- ✓ Construction of four (4) training centers in the following regions: Chapada dos Guimarães, Lago do Manso, Barão de Melgaço and Várzea Grande.

Hotel Works:

- ✓ Construction of eight (8) new hotels in the city (budget of approximately R\$ 53 million).

General Information

- ✓ Cuiabá plans to finance its World Cup project based on four sources of funds: State Government, Cities Ministry, Tourism Development Program - PRODETUR and private enterprise;
- ✓ Qualification and marketing projects in the touristic cities of the region (budget of approximately R\$ 300 million - funds coming from PRODETUR); and
- ✓ The government intends to implement a project to offer free English and Spanish courses to 80 thousand people.

Curitiba - PR

Population: 1,797,408

Gross domestic product (GDP) per capita: R\$ 17,977.00

Airport and Port Works

- ✓ Refurbishment of Afonso Pena International Airport (budget of approximately R\$ 90 million and delivery expected for the end of 2011). There is a study for the construction of a third runway in Afonso Pena Airport, at a cost of approximately R\$ 132 million. In addition, the Government of Parana has already confirmed other two projects at Afonso Pena International Airport: I) Refurbishment and Expansion of the Load Logistic Terminal (budget of approximately \$ 4 million); and II) Refurbishment of the Passenger Terminal.

Ground Transportation Works

- ✓ Subway construction (budget of approximately R\$ 2 billion). Subway construction studies and projects were tendered and are being made by Nova Modal consortium, which consists of the following companies: Trends, Engefoto, Esteio and Veja. The performance of the construction and the conclusion of the project depend mainly upon the participation of the Federal Government on its implementation.
- ✓ Overall, the expected investments for the World Cup total R\$ 4.5 billion, half of which might be destined to the construction of the subway lines;
- ✓ Urban mobility works (budget of approximately R\$ 205.6 million).

Stadium Renovation / Construction

- ✓ Completion of Joaquim Américo Guimarães - Arena da Baixada Stadium (budget of approximately R\$ 138.3 million, which value will be raised from private enterprise). Recent news report that the project is endangered, due to the fact that its feasibility has not being established. The organizing Committee said that if the Arena da Baixada project is not implemented, the city will build another stadium;
- ✓ The city intends to headquarter the Federation Internationale de Football Association ("FIFA") media center for the transmission of all games to the world;
- ✓ Infrastructure fitting works around Arena da Baixada Stadium (budget of approximately R\$ 204 million).

Hotel Works

- ✓ Expansion of the hotel network, to increase the city's hotel capacity by 2 thousand beds.

Fortaleza - CE

Population: 2,473,614

Gross domestic product (GDP) per capita: R\$ 9,325.00

Airport and Port Works

- ✓ Expansion of the international terminal of Pinto Martins International Airport (budget of approximately R\$ 517.5 million, funds guaranteed by the PAC). The works are scheduled to start until May, 2011;

Ground Transportation Works

- ✓ Construction of the VLT (Light Rail Transit Vehicle) (budget of approximately R\$ 265 million). The works are scheduled to start until January, 2011;
- ✓ Construction of Fortaleza Subway South Line (budget of approximately R\$ 1.4 billion and expected delivery in 2012). The bidding process was initiated on February 2010 and there is a confirmation that the Italian company AnsaldoBreda will provide the cars to the new subway;
- ✓ Development of a Transit and Mass Transportation Program - TRANSFOR (budget of approximately R\$ 510 million).

Stadium Renovation / Construction

- ✓ Refurbishment of Governador Plácido Aderaldo Castelo - Castelão Stadium (budget of approximately R\$ 400 million). The refurbishment works on Castelão Stadium will be financed through PPPs and there is already a group of investors interested in the projects. The group includes the following companies: Fujita, Carioca Christiani Nelsen Engenharia and Somague. Due to a legal impediment, including the threat of injunction by the Public Prosecutor Office, the bidding process is stalled and it is estimated that the winning consortium will be announced on June 10, 2010. The consortiums Marquise/EIT/CVS and Novo Castelão remains in the dispute together with the Brazilian construction company Odebrecht.

Hotel Works

- ✓ Expansion of the hotel network, to increase the lodging capacity by 12 thousand beds.

Technology

- ✓ The municipal governments intend to develop the so-called "Digital Belt", offering broad band and digital TV to more than 80% of the population.

General Information

- ✓ The state government of Ceará and the municipal government already guaranteed 60% of the investments required for the performance of all projects. R\$ 5.8 billion out of the nearly R\$ 9.4 billion that will be expended, were already received from the federal government or financing institutions, as the BID.

Manaus - AM

Population: 1.700.000

Gross domestic product (GDP) per capita: R\$ 18.902,00

Airport and Port Works

- ✓ Refurbishment and expansion of Eduardo Gomes Airport (budget of approximately R\$ 792 million, under full responsibility of INFRAERO). According to INFRAERO, the works are scheduled to start by February, 2011.

Ground Transportation Works

- ✓ Manaus - Iranduba Bridge (budget of approximately R\$ 585 million). The conclusion of the project is foreseen to December, 2010;
- ✓ Restoration of Ponta Negra Beach (budget of approximately R\$ 53 million). The revitalization shall be performed in two different stages, through a partnership between the Local Government and international banks;
- ✓ Urban mobility improvement projects (under study phase).

Stadium Renovation / Construction

- ✓ Refurbishment of Estádio Vivaldo Lima - Vivaldão Stadium (budget of approximately R\$ 400 million). The works should be initiated in the first semester of 2010, despite the fact that some initial procedures are being implemented, like the withdrawal of the movable parts of the stadium as chairs, scores, electrical installations and lighting. The grass is also being removed for application of a new one.

Energy

- ✓ Petrobrás is investing R\$ 8 billion in the construction of a pipeline in the region. This pipeline will benefit Manaus in the generation of thermoelectric power.

Sanitation

- ✓ "Igarapés" (narrow river branches or channels existing in large numbers in the Amazon basin, generally shallow and usually running deep into the forest) sanitation project (budget of approximately R\$ 800 million, financed by the BID).

General Information

- ✓ The municipal and state governments do not have a closed budget for the Games. Meetings are being held to prepare a directive plan and a bid planning for the main works. The Government's intention is to reduce the costs of the Manaus 2014 Project;
- ✓ Manaus historical center restoration (budget of approximately R\$ 300 million); and
- ✓ Rebuilding of Manaus Municipal Theater (budget of approximately R\$ 17 million).

Natal - RN

Population: 798,065

Gross domestic product (GDP) per capita: R\$ 9,500.00

Airport and Port Works

- ✓ Construction of São Gonçalo do Amarante International Airport (budget of approximately R\$ 400 million and expected delivery in 2012). The bidding process for the airport's construction conclusion shall start in July, 2010, after a meeting of the State Government with the Federal Government in order to grant to the Agência Nacional de Aviação Civil (ANAC), concession powers to the private sector the airport's construction and management.; and
- ✓ Refurbishment of Augusto Severo International Airport (budget of approximately R\$ 14 million). The works shall start on the second half of 2010.

Ground Transportation Works

- ✓ Construction of Metropolitan Village (budget of approximately R\$ 130 million and expected delivery in 2011);
- ✓ Restoration of Natal beachfront (budget of approximately R\$ 300 million);
- ✓ Construction of the Abolição Road Complex (budget of approximately R\$ 60 million);
- ✓ Improvements in the urban mass transportation (budget of R\$ 72.8 million and expected delivery in 2013); and
- ✓ VLT (Light Rail Transit Vehicle) construction project (budget of R\$ 878 million). Most of the VLT will be financed by the Federal Government, through the PAC. Actually, it has been discussed the feasibility of the project, which may be convert to BRT (Bus Rapid Transit).

Stadium Renovation / Construction

- ✓ Construction of Dunas Stadium (budget of approximately R\$ 300.8 million). The construction of Dunas Stadium will be financed by PPPs. Companies such as Acciona, Serveng - Civilsan, Bouygues, Salamanca Management Fund and Valora are already interested in bidding for these works. Bidding process started at the end of May, and the expectation is that the first phase of works shall start in the first half of 2010.

Hotel Works

- ✓ Expansion of the hotel network in the city of Natal with the creation of 33 thousand beds.

Sanitation

- ✓ Drainage and sanitation improvement works (budget of approximately R\$ 346 million and expected delivery in 2012).

General Information

- ✓ The municipal government has a manpower qualification project estimated at R\$ 20 million.

Porto Alegre - RS

Population: 1,420,667

Gross domestic product (GDP) per capita: R\$ 19,582

Airport and Port Works

- ✓ Expansion of Salgado Filho International Airport (budget of approximately R\$ 250 million and expected delivery in 2012). It is expected that the works shall start in the end of 2010, to be concluded by the end of 2012. Until this moment, there is no public bidding regarding such project.

Ground Transportation Works

- ✓ Construction of Porto Alegre subway Line 2 (budget of approximately R\$ 2.5 billion and expected delivery in 2014). The State Government is evaluating the possibility of a PPP (Public Private Partnership) to finance the subway construction works. In addition, regarding the construction of the Line 2 of Porto Alegre Subway, there is already a project related to its expansion, however it is still subject to adjustments in accordance with PAC's budget. The Federal Government has cut out the project of the first "PAC da Mobilidade" and now the construction and the implementation of Line 2 shall depend upon its inclusion in the Federal Government plans, or upon the implementation of a PPP. Initially, the government has confirming that this project will not be approved. Until this moment, there is no published bid invitation regarding the construction of Line 2 of Porto Alegre Subway.
- ✓ Development of Portais da Cidade - public transportation project (budget of approximately USD 210 million, of which USD 100 million will come from foreign financing and USD 110 million from the municipal government, private enterprise and PPPs (Public Private Partnerships) funds. Expected delivery in 2013;
- ✓ Investments of R\$ 400 million on Porto Alegre urban road system infrastructure;
- ✓ Cais Mauá Project development (budget of approximately R\$ 500 million and expected delivery in 2014). The Municipality expectation is to have a budget from the National Development Tourism Program, in order to be able to conclude the project;
- ✓ Parque Highway - BR 448 (budget of approximately R\$ 850 million and expected delivery in 2011);
- ✓ RS 010 highway (budget of approximately R\$ 350 million and expected delivery in 2014). Bid for the RS 010 will be opened soon.

Stadium Renovation / Construction

- ✓ Refurbishment of José Pinheiro Borda - Beira Rio Stadium (budget of approximately R\$ 130 million, to be financed by private enterprise only); and
- ✓ Grêmio Foot-Ball Porto Alegrense (soccer team) is also planning to renovate the Olímpico Monumental Stadium. The project has a budget of approximately R\$ 307 million, and partnership with construction company OAS.

Hotel Works

- ✓ Expansion of the hotel network in the city of Porto Alegre, with the creation of 3 thousand beds;
- ✓ Cities located at Serra Gaúcha mountain range are expected to invest around R\$ 150 million in order to attract tourists traveling to Brazil to watch the World Cup.

General Information

- ✓ Porto Alegre will make a major tourists attraction plan, mainly directed to MERCOSUL tourists

Recife - PE

Population: 1,530,000

Gross domestic product (GDP) per capita: R\$ 12,091.00

Airport and Port Works

- ✓ Renovation of Guararapes International Airport (budget of approximately R\$ 8.7 million). The main characteristic of the modernization work will be the implementation of four new boarding bridges. The expectation is that the works shall start until July 2010.

Ground Transportation Works

- ✓ Expansion of Capitão Temudo elevated walkway (budget of approximately R\$ 38.1 million). The implementation of this project has already started. The walkway shall have eight tracks (four in each direction), increasing the local traffic capacity and improving the offset between the northern and southern zones of the metropolitan area. This project budget is of approximately R\$ 33 million;
- ✓ Works on the West Side streets (budget of approximately R\$ 35.7 million);
- ✓ Works on Beira Rio Avenue (budget of approximately R\$ 52 million);
- ✓ Infrastructure works at Rua Gomes Taborda and construction of BR 101 elevated walkway (budget of approximately R\$ 85.3 million);
- ✓ A project for the construction of a VLT (Light Rail Transit Vehicle) or VLP (Bus Rapid Transit Vehicle). A Brazilian company that manufactures trains called Bom Sinal Indústria e Comércio Ltda won the competition for completion of the project. Another company called Voith Turbo (Voith Group) will provide equipments for Bom Sinal, especially regarding trains component system. The estimated value of this project is approximately R\$ 450 million. This project shall be financed through "PAC da Mobilidade";
- ✓ Construction of Perimetral III Bridge (budget of approximately R\$ 30 million);
- ✓ Construction of Semi-Perimetral Bridge (budget of approximately R\$ 23 million).

Stadium Renovation / Construction

- ✓ Construction of São Lourenço Arena (budget of approximately R\$ 500 million). The construction of São Lourenço Arena shall be financed through a PPP (Public Private Partnership) and Odebrecht, the bid winning company will have the right to exploit the Arena for a period of 30 years. The works shall start by August 2010.

Hotel Works

- ✓ Expansion of the hotel network with the creation of 2,500 beds.

Sanitation

- ✓ Drainage and sanitation improvement works (budget of approximately R\$ 346 million and expected delivery in 2012); and
- ✓ Stages II and III of Vila Mangue at South Side (budget of approximately R\$ 331 million)

General Information

- ✓ The state government enacted a bill that assures tax benefits to companies investing in projects related to the World Cup;
- ✓ Construction of Cidade da Copa [*World Cup City*] (budget of approximately R\$ 1.5 billion); and
- ✓ ADIT-NORDESTE estimates that in the next years the region will receive R\$ 20 billion in tourism-related investments.

Rio de Janeiro - RJ

Population: 6,161,047

Gross domestic product (GDP) per capita: R\$ 20,851.00

Airport and Port Works

- ✓ Refurbishment and renovation of Tom Jobim - Galeão International Airport (budget of approximately R\$ 818.9 million). Tom Jobim International Airport will have its terminal buildings expanded. The expected date to conclude this project is the end of 2013. Until now there are no public bidding notices regarding such project;
- ✓ Refurbishment and renovation of Santos Dummont Airport (budget of approximately R\$ 152.2 million); and
- ✓ The works on the airports will be financed by the PAC program, developed by the Federal Government.

Ground Transportation Works

- ✓ Bus expressway (budget of approximately R\$ 750 million and expected delivery in 2012);
- ✓ The invitation to bid for the bullet train that will connect Campinas to Rio de Janeiro was published at the end of 2009. All the public requests were consummated too. Seven consortiums are already interested in performing the works;

- ✓ With respect to the subway Line 4, there is already a concrete construction project, but a new bidding process should be conducted. Currently, the consortium responsible for this line is the consortium Rio Barra. The construction of Line 4 is expected to cost about \$ 2.7 billion and the deadline for completion of the works is 48 months from the beginning of the works. Regarding the financing structure, R \$ 2 billion should be provided through PAC da Mobilidade and the City will provide approximately \$ 700 million which will be raised through the sale of municipal land;
- ✓ Construction of "Arco Metropolitano" highway (budget of approximately R\$ 965 million and hand expected delivery in 2010);
- ✓ The construction of Metro Line 3 of Rio de Janeiro should cost about \$ 1.3 billion, 80% financed by the Federal Government and 20% financed by the State Government. A consortium formed by Queiroz Galvão and Carioca Engineering won the bid to develop the project and the deadline for completion is 42 months.

Stadium Renovation / Construction

- ✓ Refurbishment and renovation works on Jornalista Mário Filho - Maracanã Stadium (budget of approximately R\$ 430 million). Maracanã Stadium will be managed by the private enterprise through a PPP, for a period of 35 years. The Public Bidding Notice was published on June 02, 2010.

Hotel Works

- ✓ Expansion of the hotel network with the creation of 8 thousand beds (budget of approximately R\$ 1 billion).

Media

- ✓ Six local sponsorship quotas for the Cup will be marketed at amounts ranging from 40 and 80 million dollars.

General Information

- ✓ Investments in Rio de Janeiro are estimated at 10 to 12 billion Reais, of which more than half will come from partnership with the government;
- ✓ R\$ 4.7 billion out of the amount to be expended in Rio de Janeiro shall be financed through PAC;
- ✓ Rio de Janeiro is the favorite city to host the final match of the World Cup;
- ✓ The municipal government is evaluating the possibility of granting tax benefits such as the waiver of Property Conveyance Tax - ITBI, on real estate transactions with plots or buildings destined to expand the number of beds in the city for the 2016 Olympics.

Salvador - BA

Population: 2,940,000

Gross domestic product (GDP) per capita: R\$ 8,283.00

Airport and Port Works

- ✓ Expansion of Luis Eduardo Magalhães International Airport.

Ground Transportation Works

- ✓ With respect to the construction of Line 2 of Salvador Subway, the extension of the subway, the improvement and renewal of the railroader and bus system, there are no new Invitations to Bid or similar documents published, however the estimated value of the project is approximately R\$ 200 million. The only project in process is the construction of Line 1 of Salvador Subway that is being implemented since 2000, under the responsibility of the consortium Camargo Correa, Andrade Gutierrez and Siemens, this project has not been concluded so far. Today, after investigation, Bahia's parliamentarians proposed the institution of a Congressional Inquiry (CPI) to make a profound investigation regarding the non-conclusion of the works.;
- ✓ Improvements on the access to subway stations (budget of R\$ 200 million);
- ✓ Bypass lanes (budget of approximately R\$ 100 million);
- ✓ Extension of the suburban rail (budget of approximately R\$ 300 million);
- ✓ Improvement and renovation of Salvador railway system (budget of approximately R\$ 150 million);
- ✓ Bahia de Todos os Santos Expressway (budget of approximately R\$ 381 million);
- ✓ Expansion of BR 324 highway lanes (budget of approximately R\$ 300 million); and
- ✓ Renovation of the bus system (budget of approximately R\$ 50 million).

Stadium Renovation / Construction

- ✓ Refurbishment/construction of Otávio Mangabeira - Fonte Nova Stadium (budget of approximately R\$ 550 million). The Invitation to Bid to Fonte Nova's works has been published. The project it is being developed through a PPP. A consortium executed between the companies Odebrecht and OAS will be the responsible for the demolition, building and administration of the new arena.

Hotel Works

- ✓ Expansion of the hotel network with the creation of 5 thousand beds; and
- ✓ Iberostar hotel network is already investing USD 350 million in hotels and residential properties in the city of Salvador.

Construction

- ✓ The Port of Salvador will also be renovated in order to improve its infrastructure and receive a high number of cruise liners and ships during the World Cup.

São Paulo - SP

Population: 11,037,000

Gross domestic product (GDP) per capita: R\$ 25,675

Airport and Port Works

- ✓ Expansion and refurbishment of Governador André Franco Montoro International Airport (budget of approximately R\$ 1.65 billion);
- ✓ Expansion and refurbishment of Congonhas Airport; and
- ✓ Expansion and refurbishment of Viracopos Airport (budget of approximately R\$ 6 billion).

Ground Transportation Works

- ✓ Urban mobility improvement works (budget of approximately R\$ 33.4 billion, of which R\$ 25 billion will be funded by the state government, R\$ 4.1 billion by the municipal government and R\$ R\$ 1.5 billion by the federal government);
- ✓ With reference to the construction of Line 4 of São Paulo's subway, pursuant to the Call for Tender, the value placed on the project is approximately 4.7 billion reais and the term for completion of the project implementation will be the end of 2013. The construction of Line 4 is under the responsibility of a consortium ("ViaQuatro") which is constituted by 5 companies: Companhia de Concessões Rodoviárias (Brazil), Montgomery Participações (Brazil), Mitsui & Co, Ltd. (Japan), Benito Roggio Transportes (Argentine) and RATP Développement (France). The trains are manufactured by Korean company Hyundai Rotem. The project is based on a public-private partnership and funded by the Inter-American Development Bank (IDB).;
- ✓ The subway line 4 works are the first PPP initiative in Brazil;
- ✓ Implementation of the High Speed Train - TAV (budget of approximately R\$ 34.6 billion, to be financed through PAC). The governments and companies of Japan, Korea, Germany, France, Italy and Spain already expressed their interest in the development of the TAV project; and
- ✓ Construction of a 61.4 km highway connecting the Rodoanel highway with Papa João XXIII Avenue (budget of approximately R\$ 4.4 billion and expected delivery in 2010).

Stadium Renovation / Construction

- ✓ Refurbishment and renovation of Cícero Pompeu de Toledo - Morumbi Stadium (budget of approximately R\$ 250 million). The works on Morumbi Stadium will be financed by the private enterprise.

Media

- ✓ Upon completion of the 2010 World Cup (South Africa), SP Turis wants to start advertising projects regarding São Paulo throughout the world. SP Turis will spend approximately R\$ 20 million on advertising, mostly through international TV channels like CNN and ESPN. Currently, the only accomplished initiative is a website: www.spturis.com/copa2014.

V. Tax aspects related to the World Cup and Olympic Games

V.1. Federal Tax Incentives

The Special Tax Incentive System - **REIDI** for Infrastructure Development is also already in force within the federal sphere.

The legal entity that has an approved project for the implementation of infrastructure works in the transportation, port, power, basic sanitation and irrigation sectors is a beneficiary of the REIDI system

In case of sale or import of machines, appliances, instruments and new and construction equipment for use or incorporation into infrastructure works destined to fixed assets, the requirement to pay the Social Integration Contribution Program/Government Employees Savings Fund - PIS/PASEP and Social Security Financing Contribution - COFINS accruing on sales in the domestic market is suspended.

To this end, said assets or construction materials must be acquired from a legal entity beneficiary of REIDI incentives.

In the event of sale or import of services destined to infrastructure works for incorporation into fixed assets, the requirement to pay the Social Integration Contribution Program/Government Employees Savings Fund - PIS/PASEP and Social Security Financing Contribution - COFINS accruing on services provided by a legal entity established in the country is suspended, provided that said services are provided to a legal entity with REIDI benefits. Further, the PIS/PASEP on imports and COFINS - Import accruing on services are also suspended where the services are imported directly by a legal entity with REIDI benefits.

V.2. State Tax Incentives

ICMS CONFAZ² Agreement 108/08 - Authorization for the States and Federal District to grant ICMS tax exemption until 31/July/2014 on transactions with goods and assets intended to the construction, expansion, refurbishment or renovation of the stadiums that will be used in the 2014 World Soccer Cup.

Said tax benefit is applicable only to transactions which are cumulatively benefitted with: a) Import Tax or Tax on Manufactured Goods (IPI) exemption or zero-rate taxation; and b) release from PIS/PASEP and COFINS contributions.

ICMS CONFAZ Agreement 39/09 - Said agreement grants ICMS exemption to transactions related to the 2013 FIFA Confederations Cup and the 2014 FIFA World Cup.

Under said Agreement, transactions and services engaged by, or intended for, FIFA (*Fédération Internationale de Football Association*), imports included, are exempted from ICMS tax, provided that they are related to the tournaments.

Said tax benefit is applicable only to transactions which are cumulatively benefitted with: a) Import or IPI tax exemption or zero-rate taxation; and b) release from PIS/PASEP and COFINS contributions.

² Agreement on the Value-Added Tax on Sales and Services, issued by the National Public Finance Council.

ICMS CONFAZ Agreement 133/08 - The agreement authorizes the States and the Federal District to grant ICMS exemption in transactions with domestic and foreign products intended to the 2016 Olympic and Paralympics Games.

Under said Agreement, the States and the Federal District are authorized to grant ICMS exemption in transactions with domestic or foreign apparatuses, machines, equipment and further instruments and products, animals included, intended for the 2016 Olympic and Paralympics Games.

Said tax benefit is applicable only to transactions which are cumulatively benefitted with: a) Import or IPI tax exemption or zero-rate taxation; and b) release from PIS/PASEP and COFINS contributions.

It is remarkable that the provisions included in the abovementioned covenants were incorporated into the legislations of the states where the cities hosting the World Cup and the Olympic Games are located, either by amending the Tax on Distribution of Goods and Services (ICMS) respective regulations or enacting a specific legislation

V.3. Municipal Tax Incentives

São Paulo/SP

Law no. 14.863/2008 granted Tax on Services - ISS exemption where said tax is payable to the Municipality of São Paulo, on the rendering of any and all services directly related to the organization and performance of the 2013 FIFA Confederations Cup, the 2014 FIFA World Cup and the 2016 Olympic and Paralympics Games, where they are rendered by FIFA, football associations and confederations, among others.

Law no. 14.863/2008 further established: a) the requisites for entitlement to the benefit; b) the duty to comply with ancillary obligations; and c) the obligation of taxpayers benefitted with the exemption to use the Electronic Invoicing System (*Nota Fiscal Eletrônica*).

Belo Horizonte/MG

Law no. 9.721/2009 provides for the ISS exemption for FIFA.

Said Law established: a) the definitions; b) general provisions; c) FIFA's exemption; d) exemptions related to the events; e) exemptions for FIFA's business partners; and f) final provisions.

Manaus/AM

Law no. 1.353/2009 granted exemption from municipal taxes to FIFA and the entities related to the organization and performance of the 2013 FIFA Confederations Cup and the 2014 FIFA World Cup, including the rendering of services related to those events, where directly engaged by FIFA and/or its subsidiaries.

Said Law established: a) the requisites to qualify as exempt; b) the procedures and requisites for the ISS exemption; c) the right to recover in full the undue payments of the ISS tax through a simplified procedure in exceptional situations in which, for operational reasons, the ISS has been collected; d) exemptions to FIFA's Business Partners; e) FIFA's duty to provide information to the Municipal Treasury and Internal Control Department; and f) the matters subject to further regulation.

The instrument of guarantee executed between FIFA and the Municipality will be used to solve the omitted cases.

Porto Alegre/RS

Supplementary Law LC no. 605/2008 granted Services Tax - ISS, Municipal Real Estate Tax - IPTU, ITBI and Public Lighting Funding - CIP exemption to national or foreign individuals, legal entities or entities equivalent to legal entities directly related to the performance of the 2014 World Cup.

Decree no. 16260/2009 regulated LC no. 605/2008 which exempts national or foreign individuals, legal entities or entities equivalent to legal entities directly related to the performance of the 2014 World Cup from the ISS, IPTU, ITBI and CIP taxes

Said Decree established: a) the services considered directly related and necessary to the performance of the 2014 World Cup; b) the requirement for accreditation with the FIFA and nonexistence of debts or any violations vis-à-vis the Municipality to be entitled to the benefit; and c) the validity term of the benefit.

Recife/PE

Law no. 17553/2009 granted ISS exemption to FIFA and its business partners for the time that entity continues directing football worldwide.

Said Law established: a) the requisites to qualify as exempt; b) the services that are exempt from the ISS tax; c) the cases in which the exemption is limited to the services related to 2013 Confederations Cup and the 2014 World Cup; and d) the ISS exemption where the service is provided by FIFA and its partners.

Salvador/BA

Laws nos. 7721/2009 and 7722/2009 provide for exemption from municipal taxes to entities and companies that will work on the organization and performance of the 2014 World Cup and the 2016 Olympic and Paralympics Games. Concerning the Olympic Games, the exemption is limited to ISS.

Concerning the World Cup, the Law grants exemption from municipal taxes to entities related to the organization and performance of the event already confirmed for 2014; this exemption is granted to services, properties and transactions directly related to the competition. Further to FIFA, national and foreign individuals and legal entities will be exempt from ISS, IPTU, ITIV and fees established by the Municipality. One of the articles of Law 7721 further establishes that the companies providing services of construction, expansion, refurbishment and renovation of stadiums or arenas where the events will take place will be exempted from the ISS tax.

Cuiabá/MT

Law no.191, issued 2009 - grants exemption from municipal taxes to FIFA and the entities related to the organization and performance of the 2013 FIFA Confederations Cup and the 2014 FIFA World Cup, including the services related to those events, where they are directly engaged by FIFA and/or its subsidiaries.

Fortaleza/CE

Law no. 9.439/2008 exempted national or foreign individuals, legal entities or entities equivalent to legal entities directly related to the performance of the Games in the Municipality of Fortaleza from ISS, IPTU, ITBI and Municipal taxes.

Said exemption is restricted to services, revenues, income or assets directly related to and required for, the performance of the 2014 FIFA World Cup.

Said law also addressed: a) registration; b) retroactive entry in case of cancelled exemption; and c) term for regulation.

V.4. Exemptions from Other Taxes

Currently, Legislative Bill no. 7422/10 is under discussion by the Brazilian Congress. Said bill grants tax benefits to FIFA and further individuals and corporate entities involved in the 2013 Confederations Cup as well as the 2014 World Cup.

Amongst the main benefits proposed we mention the creation of the Special Tax Regime for Construction, Enlargement, Refurbishment or Modernization of the Venues (Recom).

The document also provides for the possibility of FIFA forming up to five subsidiaries in Brazil for organization and consummation of the two aforementioned competitions.

Amongst further tax measures proposed we specifically mention provisions on customs duties and import taxes; tax exemptions; as well as provisions related to immigration, customs house and check-in.

Recom Benefits

Through Recom, home market sales as well as the import of machines, devices, instruments and new equipment for construction, enlargement, refurbishment or modernization of venues will be tax-exempt from Social Integration Program Contribution (PIS), Social Security Financing Contribution (Cofins), Tax on Manufactured Goods (IPI) and Import Duty (II), among others.

The Legislative Bill also involves the acquisition of construction materials to be used in the venues.

Recom Bars

The bill bars corporate entities already enrolled in the Simplified Taxation System (SIMPLES) from joining in Recom.

Imports Release

With regard to imports, the Legislative Bill grants companies linked to, or registered in, FIFA the suspension of federal taxes to acquire assets or goods for exclusive use or consumption during the events, i.e., food, medical supplies, fuel, trophies, medals, advertising materials, print-outs, and soft goods (goods with up to 1-year shelf life).

With regard to hard goods and equipment, the document establishes that they may be imported under the Temporary Admission Special Warehouse Regime, which grants the temporary suspension of duties.

Thus, the project establishes that if the hard goods imported through that regime are exported or donated to general welfare entities after the end of competition, the tax suspensions will become tax exemptions.

FIFA's Subsidiaries

FIFA's subsidiaries set up in Brazil are also granted tax benefits dispensing with federal tax obligations, such as Corporate Income Tax (IRPJ), IPI, Tax on Financial Operations (IOF), Contribution on Net Profit (CSLL), PIS and Cofins.

According to the bill text, the benefits will also apply to corporate entities linked to FIFA which are not domiciled in Brazil, among the confederations, foreign associations and service providers which are FIFA members.

The proposal further dispenses FIFA and its subsidiaries in Brazil with the obligation to deduct the Income Tax falling on amounts paid to non-resident individuals (with temporary visa) working in the competitions. Said exemption will also benefit referees, players and further delegation members who taking part in the World Cup.

Exchange agreement operations of non-resident individuals working in the competition will also be IOF-exempt.

IPI, PIS and COFINS

The products acquired on the domestic market by FIFA, its subsidiaries in Brazil or the company broadcasting World Cup matches will be exempted from IPI, PIS and COFINS.

Project Development

The project is being conducted on a conclusive basis, i.e., it is going to be analyzed by the commissions of Economic Development; Industry and Trade; Tourism and Sports; Finance and Taxation; and Constitution, Justice and Citizenship. The bill will not need to be voted by the Plenary Session of the Brazilian House of Representatives.

However, it is important to highlight that, in the event any dissenting opinion among the commissions or any appeal against the conclusive procedure is signed by 51 representatives, the project will need to be voted by the Plenary Session of the Brazilian House of Representatives.

V.5. Agreements to Avoid Double Taxation on Income and Capital Gains

It is important to take into account the possible opportunity resulting from the application of Agreements to Avoid Double Taxation on Income in cases of athletes' activities and sponsors of sports events and promotional activities in Brazil. Incentive compensation, expenses and any form of revenue earned in Brazil during the Games may entail tax effects on the country.

VI. Financing by the National Bank for Economic and Social Development (BNDES)

BNDES launched a financing facility for the construction and refurbishment of hotels. A R\$ 1 billion facility is being made available at an interest rate ranging from 6.9% to 7.8%, plus spread. Further, the minimum transaction amount dropped from R\$ 10 million to R\$ 3 million, and the financing stake in the enterprise jumped from 60% to 80%. Such measure serves as an incentive for the country to meet FIFA's requirement of 55 thousand available beds in the host cities. The term for submission of the projects is December 31, 2012.

BNDES also launched a financing facility for the construction and refurbishment of the Stadiums that are going to be used in the 2014 World Cup. The limit amount of the loan is R\$ 400 million for each construction/renovation, and BNDES will just finance 75% of the total value of the each construction/renovation. Who makes use of this financing facility will have 3 years of lack and 12 years for the integral payment.

VII. The Olympic Act

Since confirmation of Rio de Janeiro as the host city for the Olympic Games, the International Olympic Committee (IOC) has been massively announcing its initiatives against piracy and ambush marketing by non sponsors and to this end. The IOC also relies on the commitment undertaken by the host city itself, at the time of its bidding (in compliance with the provisions of the Olympic Letter and the Host City Agreement).

Such commitment was ratified by Law no. 12.035 of October 1, 2009, which enacted the Olympic Act, and ensured guarantees and established special rules for the organization of the 2016 Olympic and Paralympic Games.

Under this law, the federal government authorities may control, inspect and restrain any wrongful acts in violation of the rights to the symbols of the 2016 Games.

The Olympic Act ratifies the protection to the Olympic distinctive signs, banners, emblems, mottos, anthems, and specifically, those related to the 2016 Games, reaffirms the prohibition to use symbols related to the Olympic Games, as well as suspends the agreements for use of advertising spaces during the forthcoming period and at the time of the games.



Recently, the Brazilian Olympic Committee - COB sent an official letter to the Federal Senate, whereby it requested that the protection granted by the Olympic Act be broadened to include "new terms or expressions whose use of combination with other elements may induce a false association with 2016 Rio Olympic Games". Those terms and expressions are: "Games", "Summer Games ", "Rio", "2016", "Two thousand and sixteen ", "twenty sixteen ", "medals", "gold medal ", "silver medal ", "bronze medal " and "sponsor".The proposal was not examined yet.

Likewise the Olympic Act, the Federal Senate is examining a bill which defines the rules on advertisings and publicity campaigns during the 2014 FIFA World Cup and 2013 FIFA Brazil Confederations Cup, to "protect and control the use of denominations, banners, mottos, anthems, trademarks, logos, and symbols associated with the events, organizers, FIFA rights' holders, the competing teams and athletes, as well as prevent the unauthorized commercial exploitation thereof".

Further to reaffirming the rights to trademarks, denominations, symbols and all other distinctive signs of the FIFA World Cup, the bill mentions "clear zones" and "clear transport zones", which are previously determined areas banning "any type of street peddling or unauthorized trade, according to the local laws", and "any type of advertising, publicity, marketing not authorized by FIFA or the organizers, or further, in conflict with FIFA rights holders' interests, on pain of fine and other penalties.
