



Participation in proceedings of structuring and due diligence of M&A operations, corporate restructuring and sale of portfolios involving health care plan operators and benefit administrators.



TRANSFER AND REGISTER

Representation in proceedings involving the request for transfer of register and portfolio or corporate control over health care plan operators and benefit administrators.



NPI's

Representation in (a) Preliminary Investigation Notifications (NIPs), which can potentially result in suspension of commercialization of plans; and (b) in violation notices served to health care plan operators/administrators.
